In the United Kingdom, taking without owner's consent (TWOC), also referred to as unauthorised taking of a motor vehicle (UTMV) and taking and driving away (TADA or TDA), describes any unauthorised use of a car or other conveyance that does not constitute theft.. TADA or TDA is specifically a criminal offence under section 178 of the Road Traffic Act 1988 that applies only to Scotland.
